- Belmont West neighborhood pool is conveniently located at 600 Chateaugay Road.
- The 2024 pool season begins (weather/circumstance allowing) the Saturday of Memorial Day weekend and closes after Labor Day (or weather permitting). During pool season, facilities are open daily from 10:00 a.m. to 9:00 p.m., unless otherwise posted.
- Pool membership and agreement is valid during the 2024 calendar year only, for the duration noted above. Membership is nonrefundable or transferable; includes one electronic key fob per membership to gain entry to pool facilities. Purchaser must be at least 18 years old.
- No prorated or reduced-price membership for a partial season membership will be offered, except for a new resident to Belmont West neighborhood after July 2024.
- There is no guaranty or promise that membership will be offered in future years.
- Pool membership does not convey any voting rights in the Belmont West HOA.
- Purchaser and all persons using said membership agree to abide by all posted pool rules. Any violation of the rules or abuse of the facilities may result in the loss of privileges and/or forfeiture of the membership. Members may bring guests at no additional cost. Members are responsible for their guests at all times during their visit.
- Members and guests assume the risk of loss or injury while using pool facilities and shall hold harmless the Belmont West HOA and the BW Executive Committee.
